All the Registered students at your centre will be henceforth be certified under Drishtee-CEEP and NSDC on successfully completion of course. Also, all the certified candidates will get an opportunity for placement support .

Center Guidelines -

There are no major changes in operational policies and will remain same for the CEEP Education Franchisees as earlier -

Guidelines as mentioned follow –

1. Adequate space for delivering training, should maintain 1:1 Computer Student Ratio.
2. Minimum one Certified Faculty in field of Courses undertaken.
3. Students should follow the curriculum patterns defined by DSDC
4. Student Assessment should be under supervision of centre in-charge and strictly follow fair practices of Examination.
5. Students will be required to fill in the registration form in newly defined format. (refer Annexure 1)

We request all the stakeholders associated with CEEP service to be informed of this change and adhere to the guidelines and regulations to be followed under said organization.
